Indonesia faces increasing challenges as both a production and distribution hub for narcotics due to its strategic position and high demand. The study highlights the rise in narcotics cases and analyzes the role of investigators in combating these crimes, as well as the obstacles they face in enforcing the law. Data collected from 2022 to 2024 shows a significant upward trend in narcotics-related cases, emphasizing the need for comprehensive strategies. This research aims to assess the effectiveness of investigative practices and identify barriers to enforcement to propose solutions for improving law enforcement outcomes.

Based on the data collected from Unit Investigation Drugs Deli Serdang Police, in three year final amount case narcotics experience significant increase, as shown in the table following:

Although the 2024 data is only reach quarterly first , but amount cases reaching 156 cases with 187 suspects indicates that circulation narcotics in the Deli Serdang area are still become threat serious in need Handling comprehensive from apparatus enforcer law .

Effects narcotics beside anesthetize and lower consciousness, is result in imagination / hallucinations (marijuana), and cause Power excitatory or stimulant (*cocaine*). Narcotics the can cause dependency (*Sylviana*, 2011).

On the other hand narcotics can cause dependence if misused so that can result in disturbance physical, mental, social, security and order society that ultimately disturbing resilience national. - b. Narcotics Group II is efficacious narcotics treatment used as choice last and can used in therapy and/ or For objective development knowledge knowledge as well as have potential tall result in dependency.
- c. Narcotics Group III is efficacious narcotics treatment and many used in therapy and/ or objective development knowledge knowledge as well as have potential light result in dependency .

In aspect legal and procedural, Deli Serdang Police are facing a number of obstacle significant. Difficulty proof be one of challenge main, especially in cases involving big dealers narcotics. Often, the evidence required difficult collected Because characteristic confidential transactions and use technology sophisticated by the perpetrators.

Time limit detention also becomes constraints , where the time given by law often No Enough For to reveal network narcotics in a way comprehensive , considering complexity and breadth network the .

4. Obstacle social and cultural

Factor social and cultural play role important in create obstacle for effort eradication narcotics in Deli Serdang. Stigma in society to family perpetrator narcotics often make public reluctant For report the cases they know, because Afraid will impact social that is possible arise . Besides that, still low awareness part public about danger narcotics become challenge alone in effort prevention and eradication.

Factor economy also plays a role significant, where the conditions tough economy push part public For involved in circulation narcotics as road shortcut look for income. This is create circle the difficult devil disconnected between poverty and circulation narcotics.

5. Obstacle geographical

Characteristics Deli Serdang's geography becomes challenge alone in effort eradication narcotics . The vast area with various characteristics diverse geography , starting from from area



urban until rural and mountainous areas, making the process of supervision and control difficult. This give chance for the perpetrators For hide activity illegal they are in difficult areas reachable

Besides that , existence Lots track mouse or track No official link that connects various regions become exploited loophole For smuggling narcotics . Pathways This often be outside range supervision routine apparatus , making it easier movement narcotics between regions without detected .

VII. CLOSING
